The organisations have built upon existing strong partnerships in the primary health and community service sectors

The Adelaide Primary Health Network have commissioned the Links to Wellbeing consortium to provide Primary Mental Health Services that will provide clinical support and psychological services across the stepped care continuum.

Interventions range from low intensity, for those with mild presentations, psychological therapies for people with mild to moderate conditions through to clinical care coordination for people with chronic and complex mental health conditions. Suicide Prevention Services for people suitable for primary mental health care management are also available.

#### Position overview

The Clinician Mental Health will work as part of a multidisciplinary mental health team to provide and facilitate the delivery of psychological group therapy sessions for adults experiencing severe mental illness in the primary care setting. Psychological Group therapeutic services are focused therapeutic interventions of varying duration suitable for low prevalent conditions such as psychotic disorders and personality disorders.

The Clinician Mental Health will be responsible for:

- Group program development and implementation
- Facilitating group therapy including but not limited to Lite DBT, Schema and Mindfulness strategies for clients experiencing Borderline Personality Disorder, as well as depression, anxiety and a range of other comorbidities.
- Developing treatment goals and plans in conjunction with patients
- Providing clinical therapeutic services (individual and group) to clients across a range of teams (adult, people at risk of suicide or self-harm) within the Central and Southern Metropolitan Adelaide
- Planning and implementing assessment and treatment services
- Liaison and consultation with other professional employees

#### Period of employment

Maximum term contracts available until 30 June 2021 (position may be extended subject to further funding); subject to a 6-month probationary period.

#### Accountability

The Clinician Mental Health is accountable to a Mental Health Clinical Lead employed by Neami National as the lead agency.

#### Conditions of employment

The terms and conditions of employment will be in accordance with the Health Professionals and Support Services Award 2010.

A number of benefits are available to staff, including generous salary packaging with rewarding NFP fringe benefit tax exemptions.

- Criminal record checks are mandatory for all new appointments. Neami will cover the cost of an
  Australian check. Where a new employee has lived outside of Australia for 12 months or more within the
  last 10 years, the cost of an International check will be borne by the applicant (~\$142.00).
- Working with Children check and Vulnerable Person check required before commencement of work (employee responsibility).

### Section C: key responsibilities

#### Clinical Services

- Clinical Group Therapy
  - Participates in the identification and development of a therapeutic group program as per operational guidelines
  - Establish methods of data capture and develop marketing strategy, selection criteria and internal referral procedures
  - Develop/source program content and materials, and implement group therapy sessions
  - Evaluate group program and conduct data analysis and report
- Provide clinical mental health services including:
  - Assess and screen referrals using appropriate tools, policies and procedures
  - Provide information about mental health and available services
  - Triage and assessment of mental health referrals
  - Work collaboratively with clients and their families to identify their mental health (and where appropriate, general health) needs
  - Coordinate client therapeutic interventions by formulating client plans in collaboration with the client, family/carers, staff and external workers and agencies, including making internal and external referrals as needed
  - Determine client goals and strategies to be implemented through therapy and review as required
  - Support the continuity and client care and information flow between clients, staff GPs and external workers and other agencies
  - Participate in psychiatric assessment and clients where appropriate
  - Provide individual and group clinical interventions as required
  - Close client files using appropriate tools, policy and procedures
- Other Clinical Responsibilities
- Participate in additional clinical responsibilities including, Clinical Supervision, Triage and Suicide Prevention Service, as determined by need and in consultation with the Senior Mental Health Clinician
- Be willing and able to provide cover for crisis and unsolicited calls or walk-ins as directed by the Clinical Lead or in their absence
- Provide leadership, secondary consultation, case review and support to other staff including clinicians, interns and youth workers as required
- Provide leadership in individual and group supervision, and attendance at team meetings and external meetings
- Liaison and Networking
- Foster and maintain relationships with external stakeholders to ensure good communication flow and clear referral pathways
- Participate in community engagement activities as directed and promote the mental health and wellbeing
  of the community
