Responsibilities & duties:

- Maintain a commitment to child safety and wellbeing, including adhering to the ACT Group's Code of Conduct and Child Safety standards in all areas of work with the ACT Group.
- Conduct Functional Behavioral Assessments and develop Positive Behavioral Support Plans.
- Work within a school environment providing individual therapy, psychological assessments, secondary consultation and professional learning and training to staff.
- Provide therapeutic support services to children, young people, families and adults.
- · Conduct intake of new referrals.
- Liaise with parents/ carers/ case workers/ guardians/ school staff, etc. in order to ensure best outcomes for children and young people we work with.
- Secondary consultations with parents/ carers/ case workers/ guardians/ school staff, etc.
- Keep appropriate client notes in a professional manner and at the standard of the appropriate professional association.
- Keep up to date with legal requirements for professional registration.
- Maintain privacy and confidentiality in relation to client information.
- Contribute to the ongoing development of clinical services program.
- Maintain regular client service hours.
- Actively participate in regular clinical individual and group supervision.
- Oversee and/or participate in specific clinical projects as required.
- Engage in networking and training opportunities as and when required.
- Adhere to compliance requirements of funding bodies, as instructed.
- Adhere to organisational policy and procedures, administration and documentation requirements.
- Ability to effectively manage multiple tasks and deadlines while maintaining productivity and personal wellbeing.
- Take on other tasks, projects as required, commencement with the position having regard to their, skills, training and experience.

In compliance with our standards for Child Safety you are also required to:

- Provide a welcoming and safe environment for children and young people.
- Promote the safety and wellbeing of children and young people to whom we provide services.
- Ensure that your interactions with children and young people are positive and safe.
- Provide adequate care and supervision of children and young people in your charge.
- Act as a positive role model for children and young people.
- Report any suspicions, concerns, allegations or disclosures of alleged abuse to management.
- Maintain valid 'working with children' documentation.
- Undergo periodic 'national criminal history record' checks.
- Report to management any criminal charges or convictions you receive prior to and during the course
 of your employment/volunteering that may indicate a possible risk to children and young people.
