Team Purpose and Contribution

The Child Sexual Abuse Therapy Service aims to reduce the harmful effects of sexual abuse on children, young people, adults and families.

The service provides person centred, trauma informed counselling, support, referral, advocacy, as well as therapeutic and educational group work. In some locations an element of support may be provided in an outreach capacity.

Role Purpose and Contribution

To provide a professional counselling service including assessments, safety planning, counselling and group work for children, young people, their parents/carers and adults who have experienced childhood sexual abuse and children and young people (under 18 years of age) who are responsible for, or who are at risk of, sexually abusing other children.

- Works closely with internal Practice Consultants and designated Clinical Supervisor. In addition to external partner agencies, Department of Communities, Child Protection and Family (CPFS), Police, Health, Aboriginal communities including Elders and other local services.
- This role supports children and young people and their families.

Key Responsibilities

Key practice responsibilities of this role are to:

- Provide counselling to children, young people and their families that is:
 - o Person Centred
 - o Evidence Based
 - o Trauma Informed
 - Culturally Safe
- Maintain and manage a case load in line with funding contract requirements
- Advocate and provide referrals as needed
- Provide flexible and responsive therapeutic interventions for children, young people, adults, and parents/carers including safety planning
- Work in an integrated service delivery model including interagency collaboration
- Demonstrate commitment to ongoing training and professional development, including supervision and annual performance reviews

This role will **provide education** by:

- Raising awareness of Child Abuse and empower individuals and groups in the community to support safe places for children to live, grow and flourish
- Develop and deliver psycho-educational/therapeutic groups for children, young people, parents/carers and adults

This role will build and influence relationships by:

- Assisting with the promotion of the program and other aspects of Anglicare WA operations, by representing Anglicare WA in both the local community and other agencies
- Representing the agency on local committees and networks as agreed with by the Service Manager
- Developing working relationships with relevant organisations, particularly those working with Aboriginal and CALD people, and individuals living with a disability
- Attending and participating in team meetings and Anglicare WA activities as required

This role will **contribute to outcome measurements** by:

- Maintaining professional documentation and administrative systems according to agency requirements, including case notes and progress reports in line with Anglicare WA and the funding body
- Maintaining statistical data collection and outcome measures

This role will contribute to a **compliance culture** by:

- Creating opportunities for client input and feedback into the design and improvement of service delivery

- Has a strong focus on the safety and protection of children and walks alongside
 individuals, families and communities to reduce the trauma and harmful effects of
 sexual abuse and into their future.
- Builds trusted community partnerships to allow for appropriate referral pathways.

Person Requirements

Knowledge and Experience

Essential

- Demonstrated counselling experience in working with children and families in a therapeutic setting, preferably in respect to child sexual abuse, inappropriate sexual behaviours and/or trauma
- Group work experience with children and/or adults
- Experience working in culturally safe and responsive ways with clients from Aboriginal and other diverse cultural backgrounds
- Awareness and/or experience working with community development models of practice
- Excellent written, oral and interpersonal communication
- Intermediate computer skills and the use of Microsoft Office Software
- Theoretical knowledge of current child and family counselling and group work literature/models
