- Proactively representing CA with key stakeholders, complex church and government networks and alliances, in order to maximise the capacity of CA to deliver on its Mission.
- Working closely with the Engagement & Sustainability and Advocacy teams and others in the organisation to deliver on the CA strategic plan.

As a manager, I am also responsible for:

- reporting and managing financial and reputational risks
- Safety & Security of in country staff

For this role I need these skills and experience:

- Extensive experience working in a faith-based international aid & development sector, managing complex programs and partnerships including in humanitarian and crisis situations.
- Demonstrated experience in leading, inspiring and developing an agile remotely-based team with varying levels of capacity.
- Proven ability in budgeting, forecasting of internal budgets and reporting in alignment with donor requirements.
- Strong interpersonal and communication skills, particularly in a cross-cultural environment.
- Demonstrated experience with strategic analysis, planning, reporting skills utilising the latest international standards in participatory program design, monitoring, evaluation and learning.
- Demonstrated success sourcing additional funding streams and capacity to travel to remote locations.

- People and Culture Business Partner, International to collaborate in regards to in country employees (Solomon Islands and PNG)
