## **Role Description**

This incumbent will work within a Family and Customer Centred Framework to provide a comprehensive centre based and consultative Occupational Therapy service to children up to 12 years of age who have difficulties with:

- Fine Motor and Hand Skills
- Visual-Motor and Handwriting
- Self-Care Skills
- Sensory/Motor Integration Skills
- Visual-Perceptual Skills
- Coordination and Gross Motor Skills

This position contributes to the success of DPV Health by operating as an Occupational Therapist Grade 2 within the Paediatric Allied Health team.

The position is responsible to provide quality Occupational Therapy intervention and expertise by working closely with the child, family, external service providers and other team members in order to best meet the child and family's needs and priorities.

Key deliverables for this role is to provide assessment, planning, treatment, education and management as an Occupational Therapist.

#### **Service Delivery**

- Provide a high quality evidence based Paediatric Occupational Therapy Service that is codesigned with the family, to meet the needs of the child and family in a manner which respects their rights and confidentiality.
- Work in partnership and collaboration with all those associated with the child/family to

  internal and external health professionals and other community team members (eg.
  preschool, school and child care staff).

- Assess, and review the child's daily living, sensory and fine/gross motor skills in order to implement interventions that will address the child/family's needs and priorities.
- Provide quality centre-based individual and group therapy services to clients.
- Ensure the standards of the Occupational Therapy service provided is based on current best practice in accordance with relevant evidence based Occupational Therapy research and the Occupational Therapy Australia Code of Ethics.
- Share knowledge and skills through participation in *Peer Support and Learning* meetings and community education.
- Identify work processes that are not working to their maximum and present possible strategies for improvement to your Team Leader.
- Embrace innovation and responsiveness.
- Achieve performance, financial and individual Key Performance Indicators as outlined in Goal Setting and Review process.
- Share knowledge and skills through participation in community education.
- Act as a resource to staff regarding current issues in Occupational Therapy.
- Manage, develop and co-ordinate the provision of language groups and resources as required.

- Provide the family with appropriate information about other available services that are relevant to the family/child and arrange any referrals requested by the family.
- Ensure client file documentation supports the standards for documentation and the quality improvement requirements within the agency.
- Work with customers and families to minimise the potential for 'Failure to Attend' clinical appointments.
- Participate in DPV Health internal meetings and represent the organisation at external meetings as required.

#### **Reporting, System and Analytics**

- Develop, implement and evaluate the effectiveness of paediatric Occupational Therapy programs in partnership with other team members.
- Ensure relevant information, statistics and documentation of practice are maintained, collated and recorded within specified timeframes (eg. TRAK progress notes, service statistics, client records and scanned documents).
- Regularly participate in designated meetings.
- Maintain timely and accurate statistical input into relevant customer management databases.
- Provide reports to the Team Leader/Manager as requested.
- Direct, supervise and assist in the training of students, volunteers and other stakeholders as required.
- Support quality improvement processes identified as relevant to the delivery of Paediatric Occupational Therapy services within the organisation
- Actively use and promote the use of DPV Health systems such as TRAK, eCase, VHIMS, MyBookings, iChris, e3 and others.
