Position Summary			
<p>Merri Health is the providers of the Victims Assistance Program (VAP) across the Northern Metropolitan and Hume regions. The VAP program is funded by the Department of Justice and Regulation (DJR) and is a network of agencies across Victoria that provides services and support to victims of violent crime against the person. The Koori Engagement Worker will work together with local Aboriginal and Torres Strait Islander and main stream organisations to participate in community engagement activities and provide support to clients who have been affected by violent crime.</p> <p>The Koori Engagement Worker provides a range of support functions to clients who have been affected by violent crime which may include intake, supportive counselling, case management, and case work. Workers aim to promote recovery through the provision of psychological first aid, support, information, advocacy, referrals, outreach, education, community links and use of limited brokerage funds. As the program covers a large region, workers may be co-located at other Community Organisations across the region. VAP employees will be supported by their Team Leader and will work with management to develop and review the VAP.</p>
