Purpose of the Position

The PTS Specialist – Child service is commissioned by Murray Primary Health Network (PHN) to deliver Primary mental Health support within a Stepped Care framework. The service is person centred and integrated with the local health system, particularly with general practice.

The program aims to;

- Deliver better outcomes for children and their families by providing evidence based, psychological interventions in a primary care setting including for people experiencing suicidal ideation where access to other services is not appropriate;
- Target services for those individuals requiring primary mental health care who are not likely to be able to have their needs met through Medicare-subsidised mental health services; and
- Compliment other services including fee for service programs and address service gaps involving rural, remote and other underserviced geographical areas and populations.
- Promote an integrated, multi-discipline, intervention approach based upon the Stepped Care approach to support individuals with mental health needs;

The PTS specialist clinician will offer more flexibility than MBS based psychology services through;

- Discussions with parents of children accessing the service
- Flexibility in service delivery modalities relevant to the needs of the child including face to face, group work and telehealth; and
- Promote local partnerships between primary mental health care services and the broader service system, including the education sector.

Key Responsibilities

- Provide PTS Specialist services to LGA's City of Albury, City of Wodonga, Indigo Shire, Alpine Shire, Rural City of Wangaratta, Rural City of Benalla & Mansfield Shire.
- Provide 6 or fewer service contacts to children accessing the service.
- Complete age appropriate relevant assessments including but not limited to the K10
- Clinical Case review to occur regularly to monitor consumers care and particularly when needed as evidence for continuation of service following 6 service contacts.
 - Case Review to involve the client, PTS clinician, any nominated family/carer or other supports, GP/Psychiatrist and other significant team members (with client consent
- Demonstration of delivery of a Stepped care approach
- Documented Needs assessment and Planning
- Documented Treatment monitoring
- Documented Exit planning
- Data entry as per PHN and Gateway Health requirements

Quality Improvement, Safety and Risk

- Maintain a safe working environment for self, colleagues, clients and members of the public

Desirable

- Passion, energy and relevant experience to make a difference to health outcomes for children through assessment, engagement and counselling.
- Demonstrated skills and experience in working within the child mental health field including counselling, group work and family support.
- Demonstrated experience in the provision of evidence based therapeutic approaches to children/young people and their families with mental health issues.
- Demonstrated understanding and experience working with families where risk factors are identified including but not limited to Alcohol & Other drug use and Family Violence.
- Demonstrated knowledge of child developmental stages, the impact of trauma, and other issues which impact on a child's health and wellbeing.
- Highly developed report writing skills, record keeping / data management, word processing and other computer skills.
- Excellent skills in engaging and working with children, young people and their families, including those from diverse backgrounds and/or with complex needs.
