PARTNER ORGANISATION OVERVIEW

The Center for Rural Development in Central Vietnam (CRD), University of Agriculture and Forestry, Hue University was established in 1995 in accordance with the Decision No. 73/QĐ-TC by Director of Hue University. CRD is committed to the mission of conducting researches, trainings, technology transfer and policy advocacy in fields of agricultural and rural development for livelihoods improvement, environmental and ecological protection and promotion of social equity and democracy. CRD focuses on 3 main fields: Sustainable development of market-oriented agriculture; Natural resources governance and biodiversity preservation; Disaster risk management and climate change adaptation with 4 integrated cross-cutting themes including indigenous culture; children protection; gender equality and good governance. CRD has been implementing projects in 14 provinces of the country, mainly in Central provinces and Western Highlands.

As an unit of University of Agrculture and Forestry, CRD has 45 staff members including 30 part-time staff mainly selected from University of Agriculture and Forestry, University of Economics and University of Science (major in sociology), and 15 full-time ones are good and excellent graduates from various training fields of Hue University. Therefore, CRD has favorable conditions to establish interdisciplinary working groups to meet the requirements of rural development activities. CRD is entitled to make decision independently and has been operating as a local non-governmental organization.

ASSIGNMENT DETAILS

Assignment overview

Established in November 7, 1995, CRD has been widely known by INGOs and international donors as a local civil society organization (CSO) in Central Vietnam working particularly on and for sustainable rural development. From 2016, with support from Save the Children International, CRD has started working in the field of child rights governance (CRG), focusing on child protection and child participation. In CRD's latest organizational strategies, child protection is defined as one of the cross-cutting issues. In addition, CRD has also developed its child rights governance strategy for the period of 2017-2021 under the support of SCI, the overall objective of which is that "CRD and other member organizations of the child right governance network in Central of Vietnam proactively involve in fulfilling the gaps identified in the CRC concluding observations".

Based on the background of CRD and the global trend observed over the last few years, CRD's approach in promoting CRG is the combination of internal and external strategic interventions which are closely interrelated and mutually supportive. One of the most significant strategic intervention is integrating CRG into CRD programs with a view to creating more outcomes and impact with respect to a number of specific child rights that CRD programs are most engaged with. In addition, CRD is also enhancing its CRG competencies and seeking opportunities to connect and cooperate with private sector to promote child rights, especially those in business principles (CRBP). In order to effectively do so, CRD is looking for a senior volunteer to provide technical assistance in child rights integrating and fund raising.
