# PLACE NAMES PROJECT COORDINATOR

Community Arts Network (CAN) is seeking expressions of interest from prospective project coordinators to work on the flagship Place Names project.

Building on Professor Len Collard's well-established research, Place Names works closely with communities to explore the Noongar language origins of town and place names using a variety of contemporary art forms that reflect language, place and identity.

CAN has produced Place Names projects in Moora, Katanning, Albany, Langford and Fremantle. The next iteration of the project is due to occur within the Perth Metropolitan area.

Working collaboratively within the CAN team and reporting to the General Manager and Program Manager, the Place Names Project Coordinator will manage the day-to-day coordination and delivery of the project in a designated community.

The Place Names Project Coordinator will:

- · have the skills and experience to work effectively in complex community settings
- demonstrate an ability to manage complex, strategic and intercultural relationships
- demonstrate a passion for community arts and cultural development
- · demonstrate a desire to engage in and learn about Noongar heritage, language and culture
- demonstrate excellent organisational and administrative skills
- a current driver's licence and the flexibility to undertake regional travel

All CAN projects engage people of Aboriginal and culturally and linguistically diverse (CaLD) backgrounds so a high level of cross-cultural competence is essential.

Priority will be given to suitably qualified applicants of Aboriginal and CaLD backgrounds.

The role is contract based, and estimated on an average of three days per week, due to commence in December 2021 for 12 months.
