PARTNER ORGANISATION OVERVIEW

Borneo Nature Foundation is a not-for-profit conservation and research organisation working for over 20 years in the rainforests of Borneo. The organisation has partnered with local stakeholders to implement landscape conservation strategies based on rigorous scientific research, and support communities to develop sustainable livelihoods that complement environmental protection.

The longest running programme, in Sebangau Landscape, was founded in 1999 as the Orangutan Tropical Peatland Project (OuTrop). Borneo Nature Foundation identified Sebangau as home to the largest orangutan population in lowland Borneo, bringing the region to the forefront of orangutan conservation efforts and resulting in the award of National Park status in 2004. In 2016, Borneo Nature Foundation has reached and tackled conservation challenges across Borneo. Borneo Nature Foundation expanded its projects in Sebangau and established Rungan Programme, working to protect 156,000 hectares of vital orangutan habitat. The foundation launched Barito Ulu Programme in 2018, working in the Heart of Borneo to revive research and conservation in the spectacularly bio-diverse and yet unprotected rainforests of northern Central Kalimantan.

Assignment objectives

Assignment overview

BNF works in three landscapes, namely Sebangau which is dominated by peat swamp forest, Rungan landscape, a mixed forest of kerangan and peat swamp; and Barito Ulu, a hill forest in the Heart of Borneo. All three are representatives of the ecosystem in Central Kalimantan. The activities carried outfocus on research, forest restoration and supporting communities to develop sustainable livelihoods that complement environmental protection. In its implementation, BNF develops cooperation and partnerships with various parties such as the central government through the Ministry of Environment and Forestry, local governments, universities and local communities.

In reducing greenhouse gas emissions, Indonesia has established a strategy for implementing NDC (National Determined Contribution) to achieve low-emissions and climate-resilient development. This NDC implementation strategy opens up opportunities for contributions from various parties, including NGOs, to participate in the achievement of NDC targets.

BNF has done many activities related to NDC achievement in Indonesia and plans to contribute more in the future. Therefore, we need an expert in climate change issues who will advise how BNF effectively communicate or report BNF activities into the NDC schemes. BNF also like to get support in linking the most emerging issues in global and region in climate change to be able to design activities meeting those issues
