

## **Position Purpose**

### Background:

The Eating Disorders Clinical Stream at Orygen is an initiative stream aimed at providing support for all areas of the clinical program in managing those young people within the service who have a severe eating disorder and other co-occurring mental health difficulties and their families/supports. The Eating Disorders Stream is an integrated clinical, research and translation program and the incumbent is expected to also collaborate with the Eating Disorders Stream leadership group in research and translation. The aims of the Eating Disorders Stream are to support the social and vocational recovery of young people, promote adaptive help seeking and wellbeing and reduce the impact of their mental health difficulties. Clinicians within the Stream are provided with relational training and supervision and may be involved in training and research.

- The Clinical Specialist -Team Leader in the Eating Disorders Stream Region B is a key leadership position within Orygen Specialist Programs (formally known as Orygen Youth Health).
- The incumbent is responsible for the provision of clinical leadership and management, training and supervision of a multidisciplinary team specialising in the provision of comprehensive case management and psychological interventions to clients attending the Eating Disorders Stream.
- The key focus of the incumbent is to enhance the capacity of mental health clinicians in Orygen to
  engage young people experiencing eating disorders and their families/supports through providing
  training, primary and secondary consultation and doing direct clinical work alongside clinicians to
  support the development of their skills.
- The role will specifically support the management of the sub-teams of the Clinical Stream and the
  implementation of one or more specialist clinical interventions within the mental health field, such as
  psychological, family, domestic violence, Alcohol and Drug, Physical Health, Ultra-High Risk for
  psychosis, and Neurodevelopmental interventions, etc. This will occur at a primary, secondary and
  tertiary level, including, direct clinical work with clients and families, supervision and mentoring of
  clinicians, and staff education and training.
- The incumbent will manage or may assist a Senior Clinician to manage one Sub-team, including
  clinical supervision arrangements, clinical governance frameworks such Clinical Review and
  throughput processes and chairing clinical review meetings as well as supporting the Stream Leader
  and Regional Coordinator with the oversight of these processes for the other Sub-teams.

- As a clinical specialist, the incumbent is expected to function autonomously as well as work collaboratively with the Continuing Care Team Coordinators and the Clinical Stream Leaders, to plan and develop services for young people and their families which are consistent with best practice standards and evidence-based care, and are in line with the strategic direction and vision of Orygen Services. This may involve undertaking specific time limited project work of relevance and collaboration with the Orygen Research and Training programs, to support quality assurance practices and enable model and practice change.
- In addition, the incumbent may be required to provide interventions to clients from a range of Clinical Streams and spend time working within other programs such as the Youth Access Team. The service operates over a number of sites and staff may be required to work from Parkville, Footscray, Wyndham, Melton, or other sites within the catchment. Orygen has an ongoing commitment to improve service accessibility and the development of new sites across the catchment area.

## **Department Description**

Orygen Specialist Programs (OSP), formally known as Orygen Youth Health (OYH), is a program of The Royal Melbourne Hospital's NorthWestern Mental Health Service.

OSP provides specialist mental health services for young people aged 15 to 24 and focuses on providing early intervention to young people with severe and complex mental illness. OSP works alongside Orygen and the National Centre of Excellence in Youth Mental Health which operates four primary mental health care headspace services in the catchment area.

Specialist clinical streams in OSP offer targeted interventions for psychotic disorders (including young people at 'ultra-high risk' of psychosis), mood disorders, personality disorders and eating disorders; and also manage co- morbid substance use disorders and neurodevelopmental disorders.

These clinical streams are multidisciplinary teams that deliver individually tailored services to the young person that comprises assessment and crisis intervention, case management, medication, psychotherapy, family support, inpatient care, group work, vocational support, educational assistance, and intensive outreach.

Additional programs focus on: forensic youth mental and refugee access. Bed-based services include the Orygen Inpatient Unit, Hospital in The Home (Orygen@Home) and YPARC. Streams are supported by the Youth Assessment Team (YAT), and Psychosocial Recovery program, Community Development program, and Orygen Training Team. # **Key Accountabilities – Position Specific**

- Support the development of high quality clinical interventions across the Clinical Stream and Orygen
  community, acute and sub-acute teams by providing clinical leadership, supervision and mentoring, as
  well as consultation, education and training to clinicians based on clinical experience working with
  young people experiencing eating disorders and other serious mental illness and/or substance use
  and disabilities and their families/supports.
- Provide effective leadership and management of a clinical team and its clinical processes in consultation with the Continuing Care Team Coordinator and the Clinical Stream Leader, including; allocation of clients, critical incident responses, clinical review, discharges, business meetings etc. This may include direct team leadership or work with another Team Leader to undertake these responsibilities.
- Provide strategic clinical leadership and direction in development of a comprehensive service delivery
  model for the Clinical Stream interventions across the Continuing Care Teams and the OSP Clinical
  Programs more broadly, in consultation with the Continuing Care Coordinator and the Clinical Stream
  Leader, including specific time limited project work and involvement with the Orygen Research and
  Training Program.
- Provide high-quality clinical care for clients of the Clinical Stream, based on clinical experience
  working with young people with serious mental illness and including on one or more specialist clinical
  interventions, such as psychological, family, domestic violence, Alcohol and Drug, Physical Health,
  Ultra-High Risk for psychosis, Neurodevelopmental and Personality Disorders interventions etc.

This may involve being primary Case Manager for a small number of clients or be delivered as a specialist addition to the work of the Case Manager.

- Manage and undertake mental health and risk assessment, psychological treatment, crisis intervention, family work and systems containment, for the client/carers/system.
- Ensure high standards of clinical care that are congruent with OSP aims client focused, accessible, responsive and consistent with best practice.
- Ensure timely completion of mental health assessments including formulation, individual service plans, crisis management plans, outcome measures, documentation of client's progress in client files (Electronic Medical Record), discharge summaries and contact sheets.
- Attendance and/or leadership of clinical review meetings.
- Work alongside other case managers and support with family or care systems.
- Participate in quality management, accreditation and ongoing improvement activities.
- Disseminate evidence based practice and relevant research outcomes.
- Manage clinical risk and actively work toward implementing risk reduction strategies.
- Comply with Safety & Service Improvement / Quality Management policies and procedures.
- Support and participate in the Health Services Occupational Health & Safety (OHS) Policies and Procedures and implement (where appropriate) at unit/service area level including reporting any incidents of unsafe work practices, sites/areas or equipment.

### **Selection Criteria**

### Formal Qualification(s) & Required Registration(s):

- Occupational Therapists:
  - Registration under the Australian Health Practitioner Regulation National Law Act (2009) with the Occupational Therapy Board of Australia.
  - An approved Degree from a recognised school of Occupational Therapy or other qualifications approved for eligibility for membership of the Australian Association of Occupational Therapy (Vic.).
- Psychologists:
  - Registration as a Psychologist under the Australian Health Practitioner Regulation National Law Act (2009) with practice endorsement as a Clinical, Forensic or Clinical Neuro Psychologist with the Psychology Board of Australia (or eligibility to enter a registrar program as a clinical, forensic or clinical neuro psychologist with the Psychology Board of Australia where relevant).
- Registered Psychiatric Nurses:
  - Registration as a registered nurse under the Australian Health Practitioner Regulation National Law Act (2009) with the Nursing and Midwifery Board of Australia.
  - o Bachelor Degree in Psychiatric/Mental Health Nursing or equivalent, or, Bachelor Degree in Nursing plus a Postgraduate qualification in Psychiatric/Mental Health Nursing.

- Social Workers:
  - An approved degree in Social Work and eligibility for membership of the Australian Association of Social Workers.

#### **Essential:**

- Comply with all legal requirements pertaining to the position including responsibility for maintaining current registration as required by your professional organisation or other applicable Acts.
- A minimum of 10 years' experience in clinical practice within the mental health field, including young people experiencing mental health disorders.
- Specific training and demonstrated expertise in the area of specialisation for this position.
- Experience and expertise in providing case management.
- Ability to develop, implement and evaluate client-centred individual service plans, risk assessments and diagnostic formulations.
- Capacity to provide, or develop skills in, integrated assessment, treatment and care for dual diagnosis clients.
- Knowledge of the rationale and evidence for early intervention in mental illness.
- Ability to work collaboratively and effectively with young people and their families.
- Capacity to develop effective working relationships, collaborations and partnerships with a range of services within the broader community service system including primary care, AOD agencies, employment and housing services, PDRSs and so on.
- Demonstrated interpersonal and communication skills (written and verbal) as well as abilities in problem solving and negotiation.
- Ability to work independently and effectively within a multidisciplinary team.
- A commitment to ongoing professional development through access to current literature, continuing education, supervision and attendance at seminars conferences etc.
- Ability to participate in policy and service development within the program and in continuous quality improvement through ongoing evaluation of services delivered to clients.
- Ability to document care as required and comply with expectations for data collection e.g. contacts.
- Willingness to work from a community-based site and across multiple sites if required.
- A current Victorian driver's licence.
- A Working with Children check.
- Current Police Check.

#### **Desirable:**

- Nursing: Evidence of current Continuing Professional Development as outlined by ACMHN or RCNA. Evidence ACMHN Credentialed Mental Health Nurse (CMHN).
- Occupational Therapists: OT Australia Accredited Occupational Therapy status (AccOT).
- Social Workers: MAASW (Acc) or AASW Accredited Mental Health Social Worker status.
- A working knowledge of community-based organisations and human services organisations.
- Computer and keyboard skills.
- Commitment to the development of integrated clinical research within the service.
- Understanding of the Children & Young Person's Act, Mental Health Act 1986 and other Acts/ legislation relevant to working with young people in a mental health setting.
- Knowledge of relevant guidelines, plans and strategies related to the mental health service system (E.g. Victorian Mental Health Reform Strategy, National Standards for Mental Health Services, etc.).
- The incumbent may be required to perform other duties as directed.
