How we value your contribution:

Remuneration package

We aim to provide an overall remuneration package that is attractive and fair. Our global remuneration framework ensures we align to local pay, employment conditions and laws, and we benchmark against the local market to ensure we offer competitive employment conditions that are appropriate to our sector.

Salary packaging

We qualify as a health promotion charity so the Australian Taxation Office (ATO) allows us to reimburse you for personal expenses without having to pay any income or fringe benefits tax that would normally be payable. These tax concessions are in addition to the income Tax Free Threshold.

Leave

You will have access to 20 days of paid annual leave each year (pro-rated for part-time employees) and receive 17.5% leave loading when you take annual leave. You will also receive 5 days paid leave between the Christmas and New Year period and other types of leave such as personal (sick or carers') leave, paid parental leave, long service leave and compassionate leave. In addition, we provide culturally significant leave for employees with commitments under Indigenous and other cultural customs, traditional laws or religions.

Paid parental leave

We provide 14 weeks paid parental leave for primary carers at full pay and 4 weeks paid parental leave for non-primary carers, In addition, upon receipt of notification from the Family Assistance Office, primary carers may access 18 weeks paid parental leave at the statutory rate.

Performance & development

Our performance and development framework enables you to work closely with your manager to plan, manage, and review your performance throughout the year. This approach also enables you to discuss development opportunities and areas for growth.

Learning & development

Our approach to learning and development will enable you to have the information, skills and knowledge needed to do your job, with targeted opportunities identified for our Aboriginal and/or Torres Strait Islander people as required. We build the capacity of our people and support you with on-the-job experience, coaching and formal learning.

Leadership

Leadership is a key priority for us. We have customized leadership programs for leaders at all levels that are focused on supporting our people to be inspired, empowered and to make an impact in their work so that together we can achieve our vision.

Study support

We are proud that so many of our people are tertiary educated and we are committed to supporting tertiary education that is relevant to your work through our global study assistance program, which includes financial support and study days. We actively encourage our Aboriginal and/or Torres Strait Islander employees to apply for study support.

Recognition

Our recognition program has been designed to recognize and acknowledge our people who live our values of Integrity, Collaboration, Empowerment and Action, in everyday activities. We recognize our people in three ways: Peer-to-peer, manager recognition, as well as length of service.

Flexible work arrangement

You will have access to flexible work arrangements. We encourage a spirit of mutual flexibility, enabling discussions between you and your manager about maintaining worklife balance.

Purpose of the role:

The Global ODA Program Advisor provides direct support and technical advice to the Global ODA Program Manager in the implementation of the organisational ODA strategy. They will identify and analyse ODA (and other institutional donor) funding trends and opportunities globally which can potentially lead to funding for The Foundation. They will support a series of exploratory activities to potentially broaden The Foundation's role, with a particular focus on Health System Strengthening. This will include developing TORs, contracting, and managing consultants, identifying potential partnerships, and managing relationships with potential new partners. They will also assist in developing broader programs of work in eye health, which are positioned to secure funding from a range of institutional donors.

The Institutional Funding Advisor (Health Systems) will own the outcomes of:

1. Advising on, and documenting approaches and strategies for engagement with ODA/institutional donors or implementing partners particularly in health system strengthening

- 2. Developing TORs, identifying consultants, negotiating contracts and managing consultancies
- 3. Supporting development of capability statements or other products to engage ODA/institutional donors and partners.
- 4. Developing donor proposals and donor budgets
- 5. Developing briefing papers and reports for senior leadership internally

6. Assisting The Foundation to identify programmatic partnering opportunities and to establish new institutional partnerships and manage existing ones

7. Other areas as directed by management, relevant to the Strategic Initiatives team and Public Affairs Division
