# **POSITION OBJECTIVES**

The Financial Counsellor will provide financial counselling services (including information, support and advocacy), community development and community education activities to eligible clients in accordance with the strategy and aims of the Northern Community Legal Centre

The Financial Counsellor will be part of the NCLC legal team working closely with the Economic Justice team to undertake work that will improve the lives of people experiencing financial disadvantage

Project specific work includes:

- Economic Justice This is a project aimed at assisting those who are at risk of homelessness
- Steps to Legal Rights and Safe Landing These projects assist victim survivors of family violence including migration and wrap around legal support and place based family violence crisis accommodation outreach

#### **POSITION RESPONSIBILITIES**

- I. Delivery of financial counselling services including assessing and analysing the client's situation, and providing comprehensive financial counselling support to assist the client in addressing their financial issues, including advocacy and negotiation, provision of information and options, client skill building, and further referral;
- 2. Participation in service delivery clinics and subsequent follow up of casework and advice services:
- 3. Participation in the collection of statistical information as required;
- 4. Identifying systemic legal and policy issues arising from Financial Counselling work and participate in the Centre's broader policy and advocacy initiatives;
- 5. The development of external relationships with key individuals and stakeholders of NCLC and supporting internal staff with advice and information on financial counselling issues arising out of casework;
- 6. Contribute to community education via written materials, speaking engagements and participation in local community networks as required;
- 7. Other tasks as directed which are consistent with the role.

# **POSITION REQUIREMENTS**

## **Essential Selection Criteria**

- I. Hold the Diploma of Financial Counselling (or equivalent) and be eligible for membership of Financial Counselling Victoria;
- 2. At least 2 years of experience as a Financial Counsellor and sound technical knowledge, in particular concerning credit and debt issues affecting clients and their rights and obligations;
- 3. Demonstrated high level time management, organisational and administrative skills;
- 4. Demonstrated high level written and verbal communication skills including communicating complex information in plain English;
- 5. Demonstrated understanding of, and sensitivity to working with people experiencing disadvantage;
- 6. Holder of a current driver's licence, with access to a vehicle and vehicle insurance;
- 7. Demonstrated computer literacy and experience in undertaking administrative duties;
- 8. Demonstrated ability to engage and communicate with support agencies, government, utility providers, relevant networks and industry bodies;
- 9. A demonstrated interest in and commitment to social justice, including awareness of issues such as homelessness, mental health, family violence, disability, drug and alcohol problems and criminalisation; and
- 10. Demonstrated ability to work as a stand alone financial counsellor.
