About us

About the position

Act for Kids provides a specialist therapy service in Cairns, working with children and young people who have experienced sexual harm or display harmful sexual behaviours. The role will include an early intervention focus and working holistically with families/parents/carers to prevent further harm. The role will work with children, young people, and families where sexual abuse and/or harmful sexual behaviours impact the safety and wellbeing of themselves, and/or other children and young people.

Key responsibilities

- Maintain a client case load as negotiated with the Program Coordinator.
- Undertake assessment related to child's experience of sexual abuse and trauma.
- Identify and work toward client goals and achieve successful case outcomes with clients.
- Develop and review safety plans with young people and protective adults related to harmful sexual behaviour.
- Deliver protective behaviour training to children and young people.
- Provide an outstanding therapeutic service to children, young people and their families who are referred to the Cairns Sexual Abuse Counselling service.

- Provide trauma informed, developmentally sensitive and culturally safe assessments and counselling supports to children and young people who have experienced unwanted sexual contact.
- Provide trauma informed, developmentally sensitive and culturally safe assessment and counselling to children and young people 10-17 to address harmful sexual behaviours.
- Encourage and strengthening supportive relationships with adult caregivers and schools.
- Enhance psychosocial outcomes for children and young people impacted by trauma.
- Attend/facilitate stakeholder meetings for the benefit of clients and develop case plans.
- Regularly attend and participate in supervision, case reviews and other case discussions as required.
- Maintain up-to-date output and outcomes data for all clients as required by Act for Kids policies and procedures.
- Maintain and develop professional skills, through supervision and professional development.
- Participate in the Act for Kids Performance Development Planning processes through monthly and annual meetings with the line manager.
- Provide quality, timely reports as required and/or requested.
- Comply with all Act for Kids policies and procedures.
- Maintain confidentiality and privacy in all matters relating to team members, clients, and procedures.
- Fulfil other tasks that your manager/s may reasonably ask you to perform.
- Act as a client/customer focused, values based team member and work collaboratively with other team members to achieve strong results across all activities at Act for Kids.
- Ensure behaviour during all work interactions is aligned to our values of being *professional, ethical, team oriented, caring, courageous* and *collaborative*.

About you

Qualifications

- Tertiary qualifications in a relevant discipline (psychology, social work, allied health).
- Where applicable, registration with the appropriate Board under the Australian Health Practitioner Regulation Agency.
- Membership of a relevant professional body where applicable eg. Australian Psychological Society, Australian Association of Social Workers, Australian Counselling Association is desirable.

Skills and experience

- At least two (2) years' experience working with children, young people and their families in similar therapeutic roles.
- Experience providing individual therapy to children, young people and their families.
- Experience with Trauma Focused Cognitive Behavioural Therapy.
- Experience delivering psychoeducation to children and adults.
- Understanding the impact of sexual abuse on child development and impacts on family.
- Knowledge of current trauma treatment trends and child protection legislation and policy reforms.
- High level of cultural awareness and experience working with families from different backgrounds, particularly Aboriginal and Torres Strait Islander people.
- Willingness to work as part of a team and to cultivate a strength-based approach.
- Well-developed communication, problem solving and interpersonal skills.
- High level time management and case load management skills.
- Ability to use electronic case management and reporting tools.
- Excellent documentation and record keeping skills.

Other requirements

- Eligibility for a positive Working with Children Check in the applicable state of employment in Australia or exemption based on professional qualifications and registration.
- Current driver's licence.
- Applicants must be eligible to legally work in Australia and proof of eligibility will be requested.
